AAUS BoD 2016 Winter Meeting Report

On February 26-27, 2016 the Board of Directors conducted its winter meeting in San Diego, CA, hosted by San Diego State University. During the meeting each committee chair submitted reports on their respective responsibilities. I am happy to report all is in order with the Academy.

Some of the highlights of the meeting are as follows:

The Standards Committee has been doing a tireless job reviewing the AAUS Manual. They have completed a rewrite of the AAUS rebreather standards, bringing them up to date and reformatting them. They are out for review at https://secure.aaus.org/2016 rebreather standards update Check them out and let us know if you have any comments or edits to consider. They are also currently working on a revision of the nitrox standards so watch for that soon.

The Statistics Committee reported they have most of the OM stats for 2015. Please note we began collecting 2015 stats January 1, 2016. If you have not submitted your stats please do so by April 1 to stay compliant.

The Membership Committee reported the OM application process is moving forward. Thank you to the committee members for reviewing each applicant and application with a detailed eye.

As you might remember, in January 2016 the BoD asked the OM DSOs to complete an online survey regarding how and where their divers were getting their outside sponsored funding. The information gathered will be used to write grant proposals hoping to get funding to assist AAUS in developing infrastructure and move forward many of the

initiatives identified in the 2015 Strategic Plan. Participation in the survey was underwhelming and we didn't get enough information to be helpful. In response, later this year the AAUS office will be contacting OMs asking for the names of the PIs that get extramural funding. With these names the AAUS office will data mine the funding source's public records for a general amount of money that supports AAUS OM diving. Watch for more details in the upcoming months.

The topic of the AAUS accreditation program, one of the highly desired initiatives identified by the 2015 Strategic Plan, was discussed. The BoD took a very ambitious position last year setting a goal of 6 program accreditations completed in 2016. At the meeting, a roll out plan for the program was presented, and after thorough discussion by the BoD, it appears this goal is achievable. A more comprehensive explanation for this plan will be in an upcoming E-Slate.

Another highly desired initiative identified by the 2015 Strategic Plan that we discussed was the DSO qualification. This initiative is moving forward and the AAUS will conduct at least one qualification this year. The qualification process this year will be by invitation, as we need to get the proper pieces in place to have a long-term, sustainable model. We anticipate conducting more qualification sessions in 2017, once we have the structure of the program in place.

Lastly, the BoD moved forward with the development of an RFP for a new computer web-based dive log/statistics collection program. We are exploring all options, from utilizing existing platforms to having a custom designed system.

All in all, this BoD meeting was very, very efficient and productive. This is a credit to the hard work put in by your BoD members. AAUS Proposed Bylaws Change

Upon recommendation of a CPA, the AAUS Board of Directors has reviewed and approved a proposed language change in our bylaws concerning the review of the AAUS finances. It is now open to the AAUS Membership for review and commentary for 60 days at

AAUS Bylaws-Page 9 Article 1, Section 1, Subsection (c) Current language- "an independent review of the financial books, records and accounts of the American Academy of Underwater Sciences shall be completed every 2 years, in accordance with generally accepted accounting principles."

Proposed language- "a compiled financial statement with full disclosure of the books, records and accounts of the American Academy of Underwater Sciences shall be completed regularly, in accordance with generally accepted accounting principles."

AAUS Achievement Awards

At the April 2015 meeting of the AAUS Board of Directors, the Board voted to change the frequency of awarding the Academy's two top honors, the Conrad Limbaugh Award and the Scientific Lifetime Achievement Award. The Academy has traditionally given out both awards annually; after consultation with the Awards Committee, the Board unanimously voted to begin alternating the two awards between years. The decision was made based largely on the Board's recognition that awardees should be able to receive their award in person as well as attend and participate in that year's annual meeting, but increasing travel costs limited the Academy's ability to provide travel support for two awardees every year. Alternation of awards is to begin in 2016, starting

with the Conrad Limbaugh award. Funding for travel of the awardees will be generated from symposium revenue.

AAUS BOD Call for Nominations

The 2016 AAUS Nominating Committee is now accepting for consideration nominations of individual members to stand for election for one Director-at-Large position on the AAUS Board of Directors. Commencing on January 01, 2017 the elected Director-at-Large candidate will serve one three-year term. An electronic poll will open on May 01 and close June 30, 2016.

Qualified candidates must be voting members in good standing with the AAUS. The nomination letter (not to exceed 300 words) is best focused on how a particular candidate can contribute to the Academy based on their academic or diving safety contributions, or previous development or not-for-profit organizational governance experience. Annual stats may be submitted at http://stats.diveaus.org. Please do not include any dives that do not meet AAUS standards, i.e. recreational dives accepted by the DCB as proficiency dives. AAUS statistics collection criteria and definitions are at http://stats.diveaus.org/Reporting/Stats_definitions.asp.

Statistical summaries are due each January and considered late 01 April.
